



Rules and Regulations for introducing IPDC Course

Bhakta Kavi Narsinh Mehta University, Junagadh has initiated two courses with Bochasanwasi Shri Aksharapurushottam Swaminarayan Sanstha, (BAPS). The contents (in book forms) are prepared by BAPS. The revised rules and regulations to implement the same are given below:

1. There are two courses i.e. IPDC-1 and IPDC-2. The colleges (Govt./Grant-in-Aid/SF) affiliated to BKNMU may offer these two courses as add on courses.
2. The students who have enrolled themselves in any programme (BA/B.Com/B.Sc./Law/B.Ed. etc) can opt this course.
3. IPDC-1 should be offered in Sem-I and IPDC-2 should be offered in Sem-II as an Add on course at UG and PG level. IPDC-1 carries two credits and IPDC-2 carries two credits.
4. Total credit score and earned credits should be mentioned in student's mark-sheet.
5. Each college offering IPDC-1 and IPDC-2 should appoint one IPDC coordinator from the existing faculties and one or more instructors/lecturers. The instructor/lecturer should have at least graduation degree and should be interested in imbibing values in students' life and proficient enough to take the IPDC. The Coordinator may also be the instructor/lecturer.
6. One batch size should be sixty in maximum for effective delivery of the contents and necessary interaction with the students.
7. The students will earn four credits as add on credits (two for each course) after successful completion of both the courses.
8. The college/university offering the IPDC should have projector, laptop/computer, internet connection, and basic audio Visual set up as these are the primary requisite for productive learning and positive outcome of the course.

9. The university should organize workshop, whenever required, to train the instructors/lecturers/coordinators. All the appointees (Coordinators and instructors) should attend this workshop to get familiar with style of the course. The university will bear all the expenses of this workshop. No T.A./D.A. will be given by the university for the Coordinators/Principals/Instructors to attend such workshops.
10. The expenditure towards running the course, if any, will be borne by the concerned college/Department.
11. The university will not charge anything from the colleges/students as examination form fee or under any other head keeping mind the importance of inculcating values in students.
12. Course Contents will be 30 hours theory/practical (two hours/week).
13. The assessment should include both continuous evaluation and end-of-semester examination.
- 14. The drawing of question paper of semester end examination and its evaluation will be done by the college itself. Marks entry on university Online Portal should be done by the colleges. The report of total students appeared with names, their total marks and obtained marks (Semester End Examination and Continuous Evaluation) and result (Pass/Fail) should be submitted to the exam section, Bhakta Kavi Narsinh Mehta University, Junagadh.**

Examination:

1: Standard of Passing the examination:

- Student must obtain at least 40 % marks separately in Semester End Examination and Continuous Evaluation.
- Candidate failing the examination as per above provisions should have to reappear for that course/component when university conducts its examination.

2: Marks of Semester End examination, Continuous Evaluation and Credits


- Total marks of theory paper are 100 (Semester End examination of 70 marks + Continuous Evaluation of 30 marks). Total number of credits of the one course is two. Student has to obtained two credit to pass the examination.

3. Structure of Question Paper of Semester End Examination

- At the end of the semester, the students will be required to take a semester end exam with multiple choice questions/objective type questions/True-false type questions, Match item of table 'A' with table item 'B' type questions based on the lectures and study materials provided. The weightage will be 70 marks.
