This is to inform all concerned that, as approved by the competent authorities of FC and BoM, the following revised fee structure for the Ph.D. Programme shall be applicable to all eligible scholars with effect from the date of implementation.

- (2) DRC Processing fees (once): Rs. 1000/-
- (3) Registration fee to be paid (once):  
Indian Scholars: Rs.2000/- (Re-registration: Rs.5000/-).  
Foreign\* Scholars: Rs.10,000/-(Re-registration: Rs.15000/-)
- (4) Coursework Fee:  
Indian Scholars: Rs.5000/-  
Foreign\* Scholars: Rs.20,000/-
