## ABOUT THE UNIVERSITY

**Bhakta Kavi Narsinh Mehta University (BKNMU)**, a State University was established by Government of Gujarat vide Gujarat Act. No 23 of 2015 on 16<sup>th</sup> September, 2015. It is situated at Junagadh city of the Saurashtra region, Gujarat State, India. The idea of new university conceived by Honourable Prime Minister Shri Narendra Modi and the seed of inception was laid down by Honourable former Chief Minister of Gujarat- Shrimati Anandiben Patel. Provisionally, the university is made functional in Government Polytechnic Building, Khadiya, which is in close vicinity of 12 kilometres from Junagadh city. The jurisdiction of the University includes Junagadh, Porbandar, Gir Somnath and Devbhumi Dwarka districts.

There are five Post Graduate departments in the University i.e. Department of English, Department of Sociology and Social Work, Department of History, Department of Life Sciences, Department of Chemistry and Forensic Science and Department of Commerce and Management and Centre of Excellence for Wild life and Conservation studies. This year two new Department of Gujarati and Department of Sanskrit Post Graduate departments will be initiated. There are 166 affiliated Government, grant-in-aid and self-finance colleges and 89 post-graduate centres in which more than 1,000,00 students are studying in various faculties viz. Arts, Commerce & Management, Science, Medicine, Law, Education at under Graduate, Post Graduate and Diploma Level.

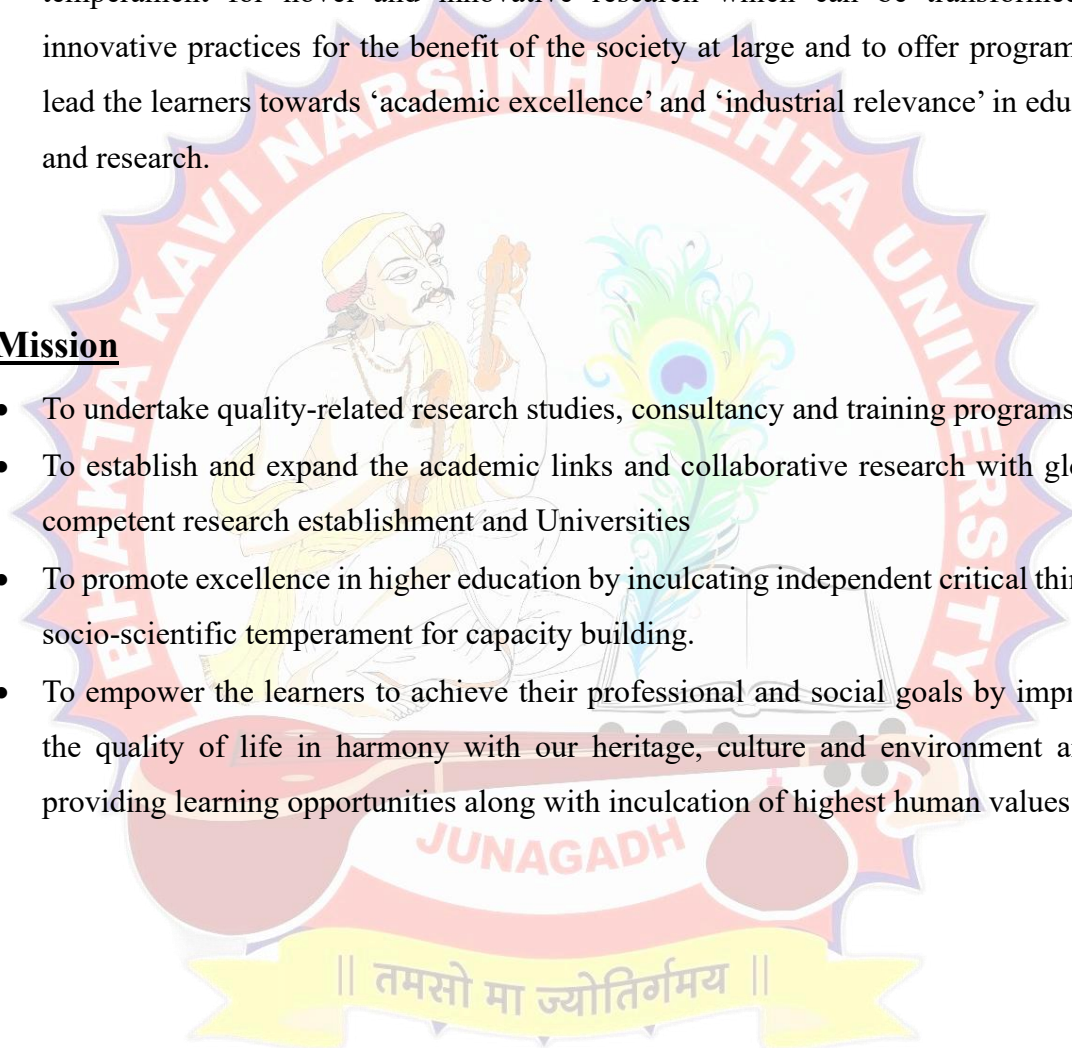
## VISION AND MISSION OF THE UNIVERSITY

### 1. GENERAL INSTRUCTIONS :

- a. **Provisional Eligibility Certificate (PEC):** Candidates who have completed their final year undergraduate studies from any university *other than* Bhakta Kavi Narsinh Mehta University must obtain a **Provisional Eligibility Certificate (PEC)** from BKNMU, Junagadh. This certificate must be submitted to the concerned postgraduate department at the time of paying the **First Semester fees**.
- b. **Reservation Policy:** University will strictly follow the rules and regulations laid down by the Government of Gujarat as applicable during the current academic session for Admissions to candidates belonging to reserved categories.
- c. **Admission Schedule:** The PG admission process for the academic year 2025–26 will adhere to the schedule and guidelines provided under the GCAS portal. (Refer: <https://gcas.gujgov.edu.in/>)
- d. **Merit List & Document Verification:** The **merit rank/list** is provisional and subject to verification of original documents at the respective postgraduate department at the time of admission.
- e. **Display of Merit List:** The list of students selected for **provisional admission** will be published on the **university website (PG Admission Portal)**. Applicants are advised to check the portal regularly for updates.
- f. **Other University Candidates: 5% of seats** are reserved for candidates from universities **other than BKNMU**. These applicants will be

considered under the **General Category**, and no reservation benefits will apply to them.

- g. **Provisional Nature of Admission:** All admissions shall be treated as **provisional** until the issuance of the **PG Registration Number/Student Permanent ID (SPID)** and are subject to final verification, confirmation, and approval by the competent authorities of **Bhakta Kavi Narsinh Mehta University, Junagadh.**

**3. PROVISION FOR RESERVED CATEGORY CANDIDATES**

- 1. Eligibility for Reserved Seats:** Reserved category seats are designated **only for students of Gujarat origin** who belong to eligible reserved categories and have passed their undergraduate examinations from **colleges affiliated with Bhakta Kavi Narsinh Mehta University, Junagadh.**
- 2. Reservation Quota Compliance:** The allocation of seats to reserved categories shall be in strict accordance with the current rules and policies of the Government of Gujarat. Admissions will be made in proportion to the total number of available seats, and candidates will be considered under the category they applied for.
- 3. Merit-Based Admission to Unreserved Seats:** **If a candidate from a reserved category secures a position in the general merit list, they may be admitted under the unreserved category, without affecting their reserved quota.**
- 4. Document Verification for Reserved Category Admission:** **Admission granted under a reserved category is provisional until the verification of valid Caste Certificate, Income Certificate, EWS Certificate, or Non-Creamy Layer Certificate by the**

**authorized university person/body. If any of these certificates are found to be invalid or not verifiable, the candidate will be shifted to the General Category.**

- 5. Interchange of Vacant Reserved Seats:** If reserved seats remain vacant after admissions—for example, SC seats may be transferred to ST candidates, and vice versa—such redistribution will follow government norms.
- 6. Reservation for Physically Handicapped (PH) Candidates:** **Candidates with a minimum 40% disability are eligible under the PH category, which carries a 5% reservation. The PH certificate must be issued by a competent medical authority and will be evaluated according to the applicable government guidelines.**
- 7. Validity of Caste Certificates:** **Caste certificates must be duly stamped, signed, and issued by a competent authority designated by the Government of Gujarat. Unsigned or unverified certificates will not be accepted.**
- 8. Non-Creamy Layer Certificate:** **OBC/SEBC candidates must provide a Non-Creamy Layer Certificate, properly stamped and signed by the issuing authority. The certificate must be valid for the financial year 2025–26.**
- 9. Failure to Submit Valid Certificates:** **Candidates who fail to produce the necessary documents—such as Caste, Income, EWS, or Non-Creamy Layer certificates—within the stipulated time will be considered under the General Category, without any exceptions.**
- 10. Reallocation of Unfilled Reserved Seats (SC/ST):** After admitting all eligible students under reserved categories, **any vacant seats under the Scheduled Caste (SC) category may be reallocated to Scheduled Tribe (ST) candidates, and vice versa, following the applicable government norms.**
- 11. Physically Handicapped (PH) Reservation:** A **5% reservation** is available for candidates with a **minimum of 40% physical disability**, as certified by a **competent medical authority**. This reservation will be applied **within each respective category** and in line with the **latest State Government guidelines.**
- 12. Validity of Caste Certificates:** All caste certificates must be valid, duly signed, and stamped by an authority officially empowered by the **Government of Gujarat**. Certificates lacking proper authentication will not be accepted for reserved category admissions.
- 13. Non-Creamy Layer Certificate (for OBC/SEBC candidates):** OBC/SEBC applicants must submit a **Non-Creamy Layer Certificate**, properly signed and

stamped by a designated authority. The certificate must be **valid for the financial year 2025–26** to be considered for reservation benefits.

**14. Failure to Provide Valid Reservation Documents:** If a candidate **fails to submit the required documents**—including valid **Caste, Income, EWS, or Non-Creamy Layer Certificates**—within the stipulated timeline, their **application will be treated under the General Category**, regardless of their original claim.

#### **4. SUPERNUMERARY SEATS:**

In addition to the regular reservation categories, supernumerary seats are allotted under the following special provisions. These seats are over and above the sanctioned intake and are non-convertible, meaning they will remain vacant if no eligible candidate is available.

##### **(a) Economically Weaker Section (EWS)**

1. 10% supernumerary seats are reserved for candidates from the Economically Weaker Section, in accordance with government regulations.
2. Of these, 33% shall be earmarked for female candidates.
3. If eligible candidates are not available, these seats shall remain vacant and will not be transferred to any other category.

##### **(b) Sports and Cultural Achievement Quota (3%)**

1. 3% of the total supernumerary seats are reserved for candidates who have excelled in sports or cultural activities.
2. Eligibility will be determined by a competent committee constituted by BKNMU.
3. Applicants must submit supporting documents along with a printout of the registration form to the Admission Committee.

##### **(c) Ex-Servicemen Quota**

1. One Reserved seat is available for children of Defence personnel and Ex-Servicemen.
2. Applicants must submit a valid certificate issued by:
  - a. The Director, Sainik Welfare Board, or
  - b. The District Sainik Welfare Officer.
3. For serving defence personnel, a certificate issued by the Commanding Officer of the respective unit is required.

##### **(d) Single Girl Child Quota**

1. One supernumerary seat is reserved for a Single Girl Child, awarded on the basis of merit.



2. A notarized affidavit is required, attested by an SDM, First Class Magistrate, or Gazetted Officer (not below the rank of Tehsildar), clearly stating that the applicant is the only girl child in the family.

Among categories (b) and (d), the candidate with the **highest merit** will be considered for admission **under the 3% supernumerary quota**.

**6. PREPARATION OF MERIT LIST**

1. **Merit-Based Admissions:** Admissions to the **First Semester of PG programs** will be strictly based on **merit**.
2. **General and Category-wise Merit Lists:** A **General Merit List** will be prepared for all applicants. Separate merit lists will be generated for candidates belonging to **reserved categories** as per applicable norms.
3. **Publication of Merit Lists:** The **provisional merit list** of selected candidates will be published on the **GCAS Portal**. Applicants are advised to check the website regularly for updates.
4. **Document Verification:** All merit rankings are **provisional** and subject to the **verification of original documents** at the respective PG departments during the admission process.
5. **Criteria for Merit Calculation:** The merit list will be prepared based on the **aggregate marks obtained across all six semesters** of the undergraduate program. For institutions following an **annual system**, the **final year marks in all subjects** will be considered.

6. **Exclusion of Grace Marks:** Grace marks or condonation marks will not be taken into account for the purpose of merit determination.
7. **Tie-Breaker Clause:** In case two or more candidates have **identical aggregate marks**, their sixth semester marks (in case of semester system) or their second year marks (in case of Yearly system) will be used as the deciding factor.
8. **Incomplete Applications:** Any application found to be **incomplete** or lacking required information/documents will be **summarily rejected**.

## **7. VERIFICATION OF DOCUMENTS**

1. **Verification of Documents:** Candidates who have submitted the **online admission form** must appear for **document verification** at their respective PG departments **as and when notified by Bhakta Kavi Narsinh Mehta University, Junagadh**.
2. **Uploading of Documents:** Applicants are required to **upload self-attested PDF copies** of all necessary documents in the designated sections of the **online application form**. Ensure **all fields** are filled in correctly. Incomplete applications or failure to upload required documents will lead to **rejection** of the application.
3. **Original Documents Required at Verification:** Candidates must **bring all original documents** at the time of physical verification for cross-checking with uploaded copies.
4. **Submission of Hard Copy Documents:** At the time of physical verification and fee payment, students must submit the following documents in two copies:
  - a. A **printed copy** of the duly filled online application form
  - b. The **application fee receipt**
  - c. **Self-attested photocopies** of all relevant supporting documents  
These are to be submitted at the **concerned PG department**.
  - d. Passport Size Photo
5. **Final Confirmation of Admission:** Candidates **provisionally selected for admission** to the First Semester must carry both **original documents** and **self-attested copies** at the time of **fee payment** to confirm their admission. Refer to the **Schedule of Admission Process** at the end of this booklet for detailed timelines.



## **8. MERIT LIST**

Students are **strongly advised to regularly check the University's official website and GCAS Portal** for the latest updates and announcements. The **First Semester fee must be paid strictly as per the admission schedule** announced by the GCAS/University. Failure to adhere to the prescribed timeline for fee payment will result in **cancellation of the admission offer**, and no claim for admission will be entertained thereafter.

### **NOTE:**

Bhakta Kavi Narsinh Mehta University reserves the **full right to reject any application** if it is found to contain **incorrect information, discrepancies, or misrepresentation** of facts at any stage of the admission process. In case of any **dispute, ambiguity, or difficulty** regarding the interpretation of admission guidelines, criteria, or clauses mentioned herein, the **decision of the Departmental PG Admission Committee 2025–2026** of Bhakta Kavi Narsinh Mehta University, Junagadh shall be considered **final and binding** to all applicants.

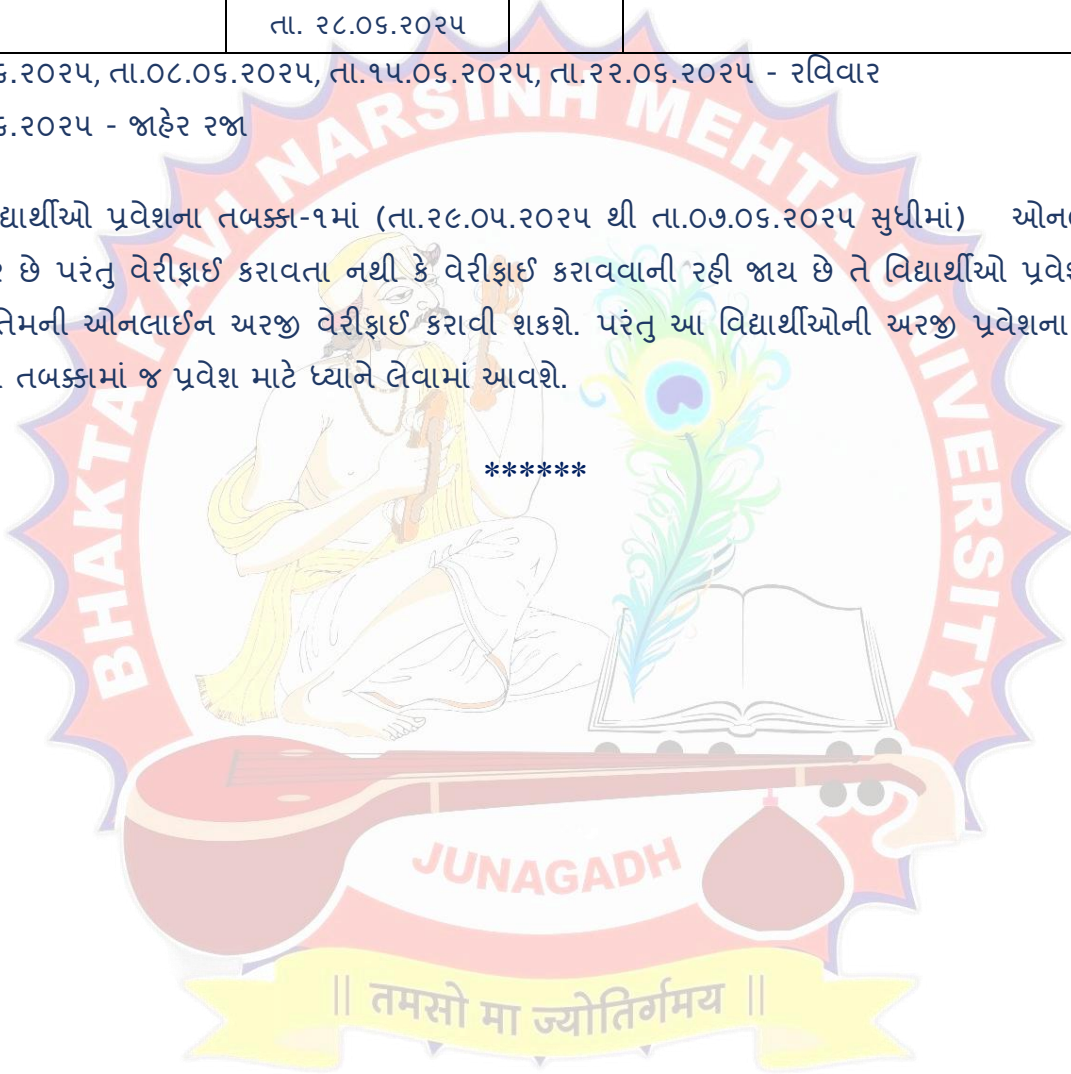
