Important Instructions:

1. This merit list is purely provisional and subject to physical verification of student's online application documents with his/her original documents. The students who fail to verify their original documents at given time schedule will be debarred from the admission process and the next merit number student will be given chance for the same.
2. The students as per the provisional merit list should come to Bhakta Kavi Narsinh Mehta University, Junagadh for verification of documents and paying the Sem-I fee. The fee structure is given in the Admission Brochure. The students have to bring the following documents at the time of paying the fee.
 - Online application, application form fee receipt with all necessary documents in one copy.(All documents should be self-attested)
 - All relevant original documents.
 - One Extra copy of: Leaving Certificate, Last exam passed marksheet, Caste Certificate(if applicable), Passport Size Photo-3, PEC/FEC(for other university students), Aadhar Card, Receipt of Fee paid for Sem-1 (It will be given to the students at the time of paying the Sem-1 fee). These documents are needed for filling up the registration form.
 - **Students must bring the attached assurance letter duly signed by the student and his/her parent in case any student uploaded 'Non-Creamy Layer' certificate and its validity is upto 31st March, 2020 only.** This is not applicable to those who have submitted 'Non-Creamy Layer' certificate of the year 2020-2021.
 - This merit list is prepared from 10 % reserved seats which were kept vacant for 'Special Exam/Remedial Exam' of BKNMU students and 'wait-listed students'.
