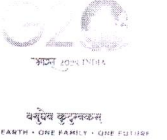

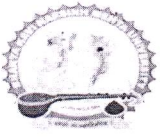

Note:

The term of the nominated members shall be for two years and six months (Dt:02-02-2024 to Dt:01-08-2026) or until they attain the age of 62 (sixty-two) years or till they hold the post for which they are nominated, whichever is earlier [except section 14(5)(b) and section 14(5)(k) as per reference (4)]. The term of the vacant/remaining members shall be as per the above time period.
