The additional terms and conditions have been incorporated by the Buyer after approval of the Competent

Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

#### **Bid Conditions**

The online quotation submitted by the bidder will be opened only if the following conditions are met. In case of non-compliance of the conditions mentioned below, the quotation submitted by the bidder will not be opened and the bid of the bidding agency will be considered as rejected.

Self-attested copies of all the documents sought must be uploaded in the GEM portal.

#### **Eligibility of Firm/Institution/Company:**

- 1. The bidder should be a registered individual/entity/organization/company in India. The address mentioned on the GST certificate will be considered as the permanent address.
- 2. If the bidding firm/institution/company is a partnership firm, a copy of the partnership document must be submitted and if the bidding firm is registered under the Companies Act or the Cooperative Societies Act, a copy of the relevant document must be submitted. In case a Power of Attorney has been given, a copy of the Power of Attorney notarized document of Rs. 300 will have to be submitted.
- 3. GST certificate, PAN card copy of the bidder/person/organization/company will have to be submitted.
- 4. A copy of the annual income tax payment details of the last 3 (three) financial years of the bidder/person/organization/company will have to be submitted.
- 5. The average turnover of the bidder/person/organization/company for the last 3 (three) financial years must be fifty percent (50%) of the bid amount. As proof of which, a CA certificate will have to be submitted.
- 6. The service center / office of the bidder/person/organization/company should be registered within 50 kilometers from the university campus, for which a proper registration government certificate will have to be submitted.
- 7. The bidder shall submit an affidavit dated after the date of announcement of tender on a stamp paper of Rs. 300 stating that the person/organization/institution/company is not blacklisted by any office/organization/department of the Government and has not been declared a defaulter by a bank/financial institution.
- 8. The signed bidding document as well as all the self-attested documents mentioned above shall be submitted with signature and stamp on all the pages in order to accept all the terms and conditions of the bid.
- 9. The original documents of all the copies mentioned above shall be submitted when asked to be produced for verification purposes.

#### **Work Details:**

- 1. Internet of 100 MBPS or more shall be provided at Bhakta kavi Narsinh Mehta University, Junagadh through point to point wireless connection in a ratio of 1:1.
- 2. The wireless connection provided shall be for backup line so that the service continues uninterrupted.
- 3. You shall provide the telephone number of the technician of the local office/service center (except toll free number) or the local office so that the university can get the service on time in case of technical failure.

#### **General Conditions of Bid:**

- 1. No conditional bid of any kind will be accepted and such bid shall be liable to be rejected.
- 2. After the bid is accepted, the bidder will not be able to withdraw their prices. If the bidder does so, action will be taken to disqualify such bidder from bidding in future as per the rules.
- 3. Bidders shall submit their bids through the portal. Under no circumstances shall the bids sent in a sealed envelope/email/paper/fax be accepted.
- 4. Only the specifications as per the specifications approved by the committee shall be accepted.
- 5. The price list of the tenders received within the stipulated time limit shall be opened before the committee appointed by the competent authority. Bids not accompanied by the required

documents as per the instructions and not having the required qualifications shall be rejected as per the decision of the competent authority/appointed committee. The duly filled price list of only those bidders who have submitted their bids with their pre-qualifications as per the rules and have submitted the necessary supporting evidence will be opened.

- 6. The authority approving the bid shall have the unlimited right to accept or reject the bid. Or the Bid Approving Officer shall have the unlimited right to accept or reject any bid submitted without assigning any reason.
- 7. The service/material as per the demand shall be delivered to the address indicated by the Bid Approving Office and a full explanation of its installation shall also be given. For which no additional transportation/labor expenses shall be paid by the Office.
- 8. The service/material shall be divided office wise as per the order of allocation given by the Office and shall be delivered to that office. For which no additional transportation/labor expenses shall be paid by the Office.
- 9. The material supplied by the bidder shall be of good quality and the service/material shall be provided as per the specification where clearly stated.
- 10. The price of each item/service in the bid shall be inclusive of all taxes and labour and transportation charges. No tax/duty/charges shall be paid separately by the Bid Approver. The Tenderer shall be responsible for paying all taxes.
- 11. Orders shall be placed as and when required, the Bidder shall not have any objection to increase or decrease in quantity and the Bidder shall be bound to supply the quantity as specified by the Bid Approving Officer.
- 12. The Bidder shall not subcontract the work to any other person/entity without the prior approval of the Bid Approver. Even if such prior approval is given by the Bid Approver, the entire responsibility thereof shall remain with the Bidder.
- 13.
